Summer 2025 weather outlook

The Bureau of Meteorology's long-range forecast for Queensland from January to March 2025 suggests above-average rainfall along parts of the eastern coast. Warmer than usual days and nights are expected across much of the state, reflecting broader national trends.

The long-range forecast for January to March shows:

- above average rainfall is likely for far eastern coastal regions and for much of western and northern Australia
- · rainfall is likely to be within the typical range for the season for most remaining areas

- · an increased chance of unusually high rainfall for parts of western and northern Australia
- · warmer than average days are likely across large parts of the country
- warmer than average nights are very likely across almost all of Australia with an increased chance
 of unusually high overnight temperatures nationwide.
